First association established to promote and develop Puerto Rico's renewable energy industry.

Implemented a **communications strategy whose informative and educational content broke through institutional opposition** to renewable energy from public corporations, the legislature, and public opinion.

Established its reputation as technical experts by developing and proposing the **Minimum Technical Requirements (MTRs)** to protect the distribution grid and enable the integration of thousands of MW of renewable energy sources.

Catalyzed and compelled PREPA to adopt the MTR framework, initiating the interconnection of utility-scale projects in Puerto Rico.

Active participants and promoters of Puerto Rico's first energy reform law, Act 57-2014, which created the Puerto Rico Energy Bureau and paved the way for renewable energy integration at all scales.

Recognized as the **most credible source of industry information** regarding renewable energy technologies and market behavior.

Brought together regulatory and legislative bodies in Puerto Rico to listen to and address the industry's needs with specific, assertive actions and legislation, benefitting renewable energy across all modalities and scales.

Responded to public concerns **with scientific and practical solutions**, enabling the responsible and sustainable development of the renewable energy industry.

Supported and actively participated in the growth of Puerto Rico's agricultural sector while protecting the environment and local communities.
